Only a parent or *guardian may register a student for the Cresskill Public Schools.

Children must be 5 years of age on or before October 1st to enter kindergarten and 6 years of age by October 1st to enter first grade from a private school.

Applications for admissions on a tuition basis (non-Cresskill resident) must include a letter from the parent/guardian to the Cresskill Superintendent requesting admission.

**CRESSKILL PUBLIC SCHOOLS
NON-RESIDENT STUDENT TUITION CONTRACT
FOR THE 2019-2020 SCHOOL YEAR**

1. Acceptance and assignment to school/class of non-resident student is a privilege, which is subject to class size, and enrollment factors in the Cresskill Schools.
2. Acceptance for the upcoming school year (2019-2020) does not imply automatic continuation for the following year or into the Cresskill School District. It shall be necessary for you to reapply each year as a non-resident for continuation of attendance of your child in the Cresskill Schools.
3. Acceptance of your child as a non-resident student is on a tuition basis (cost of which is determined each year). Payment of tuition is payable in two (2) installments due at the beginning of each semester.
4. Tuition rates are as follows for the 2019-2020 school year.

• ½ Day Pre-School:	\$ 3,950.00
• Kindergarten:	\$12,186.00
• Grades 1-5:	\$13,433.00
• Grades 6-8:	\$13,140.00
• Grades 9-12:	\$14,438.00
• Pre-School Disabled (part time):	\$32,760.00
• Autistic program:	\$60,298.00
• LLD:	\$32,560.00
• Multiple Disabilities:	\$43,994.00
• CSI Program:	\$45,554.00

In addition to the annual tuition costs as determined above, you must also pay the actual costs of any special education services required by your child. If the Cresskill School District determines that your child requires such services after the school year commences, you shall be expected to pay the prorated cost of such services.

5. The Cresskill Board of Education does not assume any responsibility for the transportation of your child to and from school.
6. Approval of this child's attendance, as a non-resident student, should not be construed to imply approval of any other of your children as non-resident students in the Cresskill School District.
7. An interview of you and your child with the building principal and/or his/her representative will be held prior to admission, results of which must be acceptable to the district in its sole discretion.
8. A copy of your child's record from his/her last school of attendance shall be furnished before the scheduled interview.

9. The parties hereto recognize that your child does not have the right to enroll in the Cresskill Public School District. Enrollment is a privilege which may be revoked by the Board at any time. You and your child hereby agree to ensure that your child complies with the rules and regulations of the School in which he/she is enrolled, the rules and regulations of the Board and the laws of the State of New Jersey. Failure to comply with any of the foregoing laws, rules and regulations shall result in the imposition of disciplinary action, which may include the exclusion of your child from the Cresskill Public School District. Should your child be excluded from the Cresskill Public School District, you shall immediately enroll your child in the school district in which he/she is domiciled or another public or private school.
10. If you do not pay the tuition due under Paragraph 3 when it is due and payable, your child shall be excluded from the Cresskill Public School District. If excluded for non-payment of tuition you agree to pay all costs including reasonable attorney fees, related to the collection of any monies owed the Board.
